- 14. Canvassing in any form shall disqualify the candidates. No inquiry or correspondence will be entertained.
- 15. No TA/DA is admissible. Duration of each test can be 02 to 05 days or more. Candidates will make their own arrangement for lodging/boarding during the test. Depot will NOT make any arrangements.
- 16. Any dispute with regard to the recruitment will be subjected to courts having jurisdiction in Hoshiarpur, (Punjab)
